7	Insurance plan in English valid in the Republic of Korea covering repatriation, medical treatment, and hospitalization (Covering duration of 1 Year, minimum 40,000,000 KRW / 30,000 EUR)
8	Medical certificate or doctor's letter written in English issued within 3 months
9	Copy of your current school enrollment letter OR copy of final education certificate/degree
